Mentle Cookie Policy

When you access and/or make use of our Services, we send one or more cookies (small text files containing a string of characters) to your device that uniquely identifies your browser. By using our site, you agree to our use of cookies.

• Targeting and advertising cookies: These cookies record your visit to our website and

your browsing habits, such as the pages you have visited and the links you have

followed. They are used to deliver advertising that is more relevant to your interests

and may limit the number of times you see an advertisement. They may be placed by

us or by advertising networks with our permission. Please note, that these cookies do

not contain any of your personal information.

• Social media cookies: These cookies enable social media functionality and track

activities like content sharing with friends and networks on social media.

Session Cookies: Any of the above-mentioned cookies may be a session cookie.

Session cookies are not permanent and only remain on your device or computer from

the point at which you visit our Service until you close your browser. Session cookies

are automatically deleted when you close your browser.
